Overview

The 6th Annual
Conference on Social Work
in the Global Environment
was held on Friday
November 17, 2017 from 8
a.m. to 4 p.m. in the
McFarland Student Union,
at Kutztown University of
Pennsylvania. The aim of
the Social Work in the
Global Environment
Conference is to contribute
to the local-global
perspectives in social work,
utilizing the strategy:
Thinking globally and
acting locally. The theme
for the 2017 conference was
“How do we build a fair,
just, and peaceful world?
Local efforts with global
implications”

The conference program
focused on globalization,
industrialization,
environmental injustice and
racism and judicial recourse,
grassroots environmentalism,
global conflicts, and local-
global responses in building
ecological and
environmental literacy.



The conference featured an
invited keynote speaker
from Moravian Academy

and ten juried paper presentations by faculty and students from Kutztown University and Rutgers University.



In attendance at the conference were participants from our local communities, faculty and students from Rutgers University.



Of the 380 attendees, 33 completed and returned the conference evaluation questionnaire. Out of the 33 respondents 11 were graduate students, 4 were undergraduate students, 11 were faculty members and 7 were others.

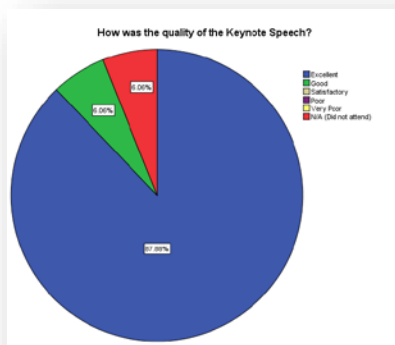


Approximately 78.79% of the respondents were Social

Work Major and 18.18% were from other majors and the remaining 3.03% did not respond.

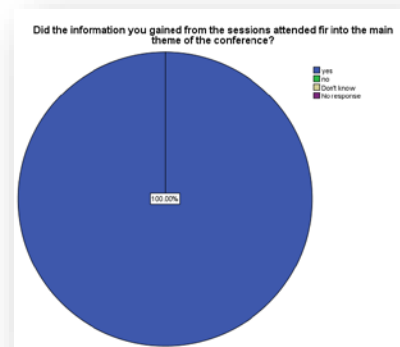


Over half (63.6%) of the respondents heard about the conference from their course instructors and via KU email announcement.

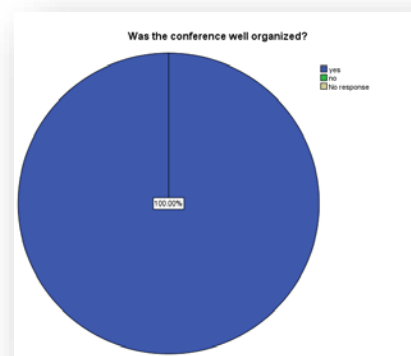


The results indicated that that over 93.94% of the respondents rated the keynote speech as excellent or very good and noted that the speaker was knowledgeable about the theme of the conference; 90.91% of the respondents indicated that the discussion held after the keynote speech was satisfactory; 100% of the respondent indicated that the information gained from the

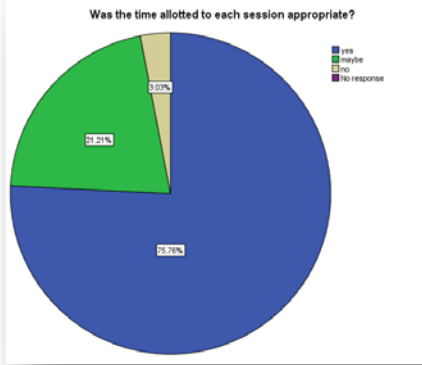
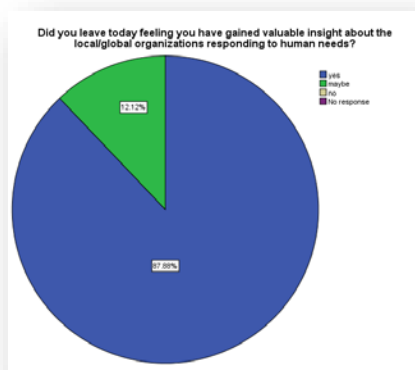
sessions was congruent to the main theme of the conference;



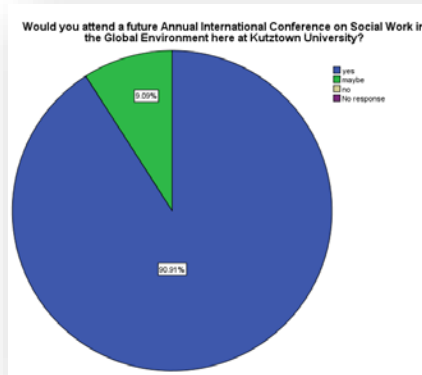
100% of the respondents rated the conference as well organized;



87.88% of the respondents rated the presentation sessions offered at the conference as excellent or very good while 6.06% rated it as satisfactory. Finally, 75.76 % of the respondents indicated that the time allotted for each session was appropriate.

90.91% of the respondents

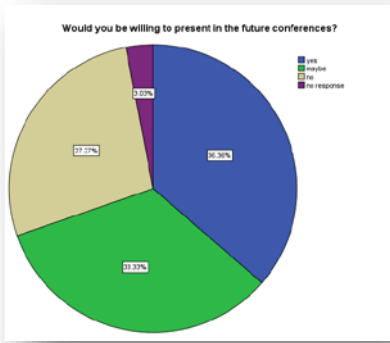
indicated that they would attend a future Annual Conference on Social Work in the Global Environment at KU and would recommend others to attend the conference. In terms of their involvement, 36.36% of the respondents indicated that they would be willing to present in future conferences; 33.33% indicated that they might present in the future conference and the 27.27% indicated that they would not present in future conference. Some of the items drawn from the qualitative responses are reported below. Overall this was a successful conference.

The results further indicated that 87.88% of the respondents gained gain awareness and understanding of the local/global organizations
