Minutes of Faculty Senate Meeting January 5, 1967

The meeting of the Faculty Senate was called to order by the Chairman, Dr. Robert Hedrick at 4:00 p.m., Thursday, January 5, 1967 in the Conference Room.

Those present were: Dr. Beekey, Dr. Dreisbach, Dr. Dustan, Mr. D. Evans, Dr. Kaiser, Mr. Knedler, Mrs. R. Mathias, Dr. Mantz, Dr. Skeath, Mr. Slick, Mr. Tinsman, Dr. Weiss, Miss Willits, Mrs. Yost. Those absent were: Mr. Patton, Dr. Monroe, and Mr. R. Thomas.

On a motion by Mr. Tinsman and a second by Mrs. Yost, the minutes of the meeting of November 3, 1966 were corrected as follows: Manufacturing Geography to read Geography of Manufacturing; Library Enrichment Materials to read Enrichment Materials; Geometry of Numbers to read Geometry and the Real Numbers.

Dr. Skeath read the final report of the Ad Hoc Committee on the review of the Student Advisory Program. Dr. Beekey commended Dr. Skeath and his committee for a fine job. It was moved by Mr. Knedler and seconded by Miss Willits that the verbal report be received and that the report will be acted upon at the next regularly scheduled meeting when all members have had an opportunity to review the mimeographed copy. Other members of the committee were Dr. Sawyer and Mr. Gledhill.

The first item under New Business was the report of the Committee on Curriculum and Research given by Dr. Beekey for Dr. Buckalew. Dr. Beekey recommended the following report be approved by the Faculty Senate. Mr. D. Evans offered the second. The Senate approved:

- B. That the course on International Organization be reactivated.
- H. That Descriptive Physics be approved as a new course.
- I. That the Biology 312 Physiology be changed to Plant Physiology.
- J. That Biology 320 Taxonomy be changed to Taxonomy of Vascular Plants.
- K. That Field Botany and Field Zoology be deleted from the list of courses.
- L. That Introductory Ecology be approved as a new course.
- M. That Ornithology be approved as a new course.
- N. That Biological Research be approved as a new offering. (1-3 credits)
- 0. That Parasitology be deleted from the list of graduate courses.
- P. That Advanced Invertebrate Zoology be approved as a graduate course.
- Q. That Parasitology be offered as an undergraduate course.
- R. That Patterns and Processes in Biology be approved as a course for in-service teachers. (2 credits) (all courses are for 3 semester hours credit, unless otherwise indicated)

The report of the Academic Council was given by Dr. Beekey. The committee recommended that any psychology course listed in the college catalog be accepted as a social science elective in the liberal arts curriculum. Dr. Beekey moved the adoption of the report and Dr. Mantz gave the second. The motion passed.

A report of the results of the election of new members to the Committee on Recruitment and Dismissal was given by Dr. Beekey. The faculty elected Mr. Tinsman and Dr. Ryan. Two others were appointed by Dr. de Francesco, they were Mrs. Sloat and Miss Matula.

The last item on the agenda was the appointment by the Chairman, Dr. Hedrick, of Mr. Tinsman to head the Ad Hoc Committee on the study of the availability of grants.

The next regularly scheduled meeting is Thursday, March 2, 1967 at 4:00 p.m. in the Conference Room.
