MINUTES OF THE FEBRUARY 27, 2003 MEETING

MINUTES

It was moved by C. Lottes and seconded by L. Kane to approve the Minutes of January 23 and January 30, 2003. MOTION PASSED.

OLD BUSINESS

Curr # : EDU 0313
Concentration: New Concentration - MBA – School Business Management (effective Summer I, 2003).
Proposal: Addition of a concentration in School Business Management to the MBA program consisting of 12 semester hours of graduate education courses as electives in the MBA program.
Comments: It was noted that the cover sheet now includes a signature from the College of Business.

It was moved by E. Rogol and seconded by K. Kresge to remove this proposal from the table. Motion Passed. It was then moved by K. Kresge and seconded by L. Kane to consider and approve this proposal. MOTION PASSED.

LAS 03071 - K. Johnston announced that this proposal should be removed from the agenda.

Curr # : LAS 03074
Course: New Course - FRE 360, Study Abroad Experience, 1-6 c.h., 1-6 s.h. (effective Summer I, 2003).
Proposal: Addition of course to master course listing. This course is available only to students majoring, minoring or earning an Elementary Education concentration in French who complete an approved study abroad program and meet evaluation standards approved by the French advisor.
Comments: It was noted that a copy of the syllabus with the suggested editorial changes needs to be forwarded to the curriculum office.

It was moved by D. Lynch and seconded by L. Kane to remove this proposal from the table. Motion Passed. It was then moved by D. Lynch and seconded by R. Schaeffer to consider and approve this proposal. MOTION PASSED.

NEW BUSINESS

College of Education

Curr # : EDU 0320
Course: New Course - EDU 015, College of Education: First Year Seminar, 1 s.h., 1 c.h. (effective Fall 2003).
Proposal: Addition of course to master course listing. This course will be required of all entering freshmen and transfer students who have less than thirty credits. The course will be offered as Pass/Fail.

It was moved by D. Lynch and seconded by L. Kane to consider and approve this proposal.
MOTION PASSED.

Curr # : EDU 0321
Course: New Course - ITC 321, Instructional Technology in Education, 3 s.h., 3 c.h. (effective Fall 2003).
Proposal: Addition of course to master course listing. This course is for use by students majoring in Special Education.
Comments: After discussion, it was decided to delete the last sentence of the course description.

It was moved by L. Kane and seconded by K. Kresge to consider and approve this proposal with the editorial change of deleting the last sentence of the course description. MOTION PASSED.

Curr # : EDU 0322
Course: Course Revision - SEU 390/391, Student Teaching and Practicum I and II (effective Fall 2003).
Proposal: Reduction in the number of credits hours to 12.
Comments: R. Schaeffer voiced his objection to the reduction in credit hours and the inequity in that, depending on the major, certain student teachers will receive only 12 credits for student teaching while others will receive 14 credits.

It was moved by D. Lynch and seconded by L. Kane to consider and approve this proposal. MOTION PASSED with R. Schaeffer opposing.

Curr # : EDU 0323
Program: Program Revision - BSED/Elementary Education (all concentrations) (effective Fall 2003).
Proposal: Reduction in the total number of credits required for graduation to 120 by revision of the program as follows: move PSY 110 from the Professional Courses section to Category 3b under General Education; move PSY 140 from the Professional Courses section to Category 3d under General Education; addition of Freshman Seminar to the Professional Courses section of the check sheet; addition of notation

to "notes" section of the Early Childhood Education concentration that ELU 130 will substitute for PSY 110 in general education and ELU 236 will substitute for ELU 366 in specialization if student completes this concentration and that if concentration is changed, then PSY 110 and ELU 366 must be completed; courses required under ACT 354 are highlighted so students know that these courses must be completed by their 48th credit or risk being dismissed from the major; and addition of ELU 3xx, Diversity and the Young Child, to the electives section in the Early Childhood Education concentration.

Comments: It was noted that reference to ELU 3xx, Diversity and the Young Child, needs to be removed from the check sheet since the course has not yet been approved by the University Curriculum Committee.

It was moved by L. Kane and seconded by K. Kresge to consider and approve this proposal. MOTION PASSED with the editorial correction of removing ELU 3xx, Diversity and the Young Child, from the check sheet.

Curr # : EDU 0324
Program: Program Revision - BSED/Library Science (effective Fall 2003).
Proposal: Reduction in the total number of credits required for graduation to 120 credits by revision of the entire check sheet. In addition, replacement of the original one grid sheet with two grid sheets, one marked "freshmen" for those students required to take EDU 015 and a separate one for transfer and other students not required to take EDU 015.

Curr # : EDU 0325
Program: Program Revision - BSED/Library Science with Dual Certification in Elementary Education (effective Fall 2003).
Proposal: Reduction in the total number of credits required for graduation to 120 credits by revision of the entire check sheet. In addition, replacement of the original one grid sheet with two grid sheets, one marked "freshmen" for those students required to take EDU 015 and a separate one for transfer and other students not required to take EDU 015.

It was moved by D. Lynch and seconded by L. Kane to consider and approve EDU 0324 and EDU 0325 as a block. MOTION PASSED.

Curr # : EDU 0326
Program: Program Revision - BSED/Special Education/Visually Impaired and IC/Special Education/Visually Impaired (effective Fall 2003).
Proposal: Reduction in the total number of credits required for graduation to 120 credits as follows: deletion of ELU 110 and ELU 120 from Section C. Specialization; addition of ELU 366 to Section C. Specialization; deletion of ITC 125 and ITC 331 from Section B. Professional Education; addition of ITC 321 to Section B. Professional Education; addition of EDU 015 to Section B. Professional Education; and cross count PSY 140 under Section B. Professional Education, and General Education Category III.D., Social Science Elective.

Curr # : EDU 0327
Program: Program Revision - BSED/Special Education/Mentally and Physically Handicapped and IC/Special Education/Mentally and Physically Handicapped (effective Fall 2003).
Proposal: Reduction in the total number of credits required for graduation to 120 credits as follows: deletion of ELU 110 and ELU 120 from Section C. Specialization; addition of ELU 366 to Section C. Specialization; deletion of ITC 125 and ITC 331 from Section B. Professional Education; addition of ITC 321 to Section B. Professional Education; addition of EDU 015 to Section B. Professional Education; and cross count PSY 140 under Section B. Professional Education, and General Education Category III.D., Social Science Elective.

It was moved by D. Lynch and seconded by L. Kane to consider and approve EDU 0326 and EDU 0327 as a block. MOTION PASSED.

Curr # : EDU 0328
Program: Program Revision - BSED/Special Education/Speech-Language Pathology (effective Fall 2003).
Proposal: Reduction in the total number of credits required for graduation to 120 credits by (1) cross counting PSY 110 under Professional Courses and General Education Category III.B. Social Science (Sociology/Anthropology/Psychology) and (2) addition of EDU 015 to Section B. Professional Education.
Comments: It was noted that the top of the revised check sheet needs to be changed to show that 120 credits are required for graduation.

It was moved by D. Lynch and seconded by L. Kane to consider and approve this proposal.
MOTION PASSED with the editorial correction of changing the top of the revised check sheet to 120 credits.

Program: Program Revision - BSED/Secondary Education/Citizenship Education – Geography (effective Fall 2003).
Proposal: Reduction in the total number of credits required for graduation to 120 credits as follows: deletion of EDU 326 from Section B. 2. Professional Semester; addition of EDU 015 to Section B. 1. Professional Courses; reduction in the number of credits from 7 to 6 credits for SEU 390 and SEU 391 under Section B. 3. Student Teaching; and cross listing EDU 100 under Professional Courses and General Education Category 2. C. Humanities Elective.

Program: Program Revision - BSED/Secondary Education/Citizenship Education - History (effective Fall 2003).
Proposal: Reduction in the total number of credits required for graduation to 120 credits as follows: deletion of EDU 326 from Section B. 2. Professional Semester; addition of EDU 015 to Section B. 1. Professional Courses; reduction in the number of credits from 7 to 6 credits for SEU 390 and SEU 391 under Section B. 3. Student Teaching; and cross listing EDU 100 under Professional Courses and General Education Category 2. C. Humanities Elective.

Program: Program Revision - BSED/Secondary Education/Citizenship Education - Civics and Government (effective Fall 2003).
Proposal: Reduction in the total number of credits required for graduation to 120 credits as follows: deletion of EDU 326 from Section B. 2. Professional Semester; addition of EDU 015 to Section B. 1. Professional Courses; and reduction in the number of credits from 7 to 6 credits for SEU 390 and SEU 391 under Section B. 3. Student Teaching.

It was moved by D. Lynch and seconded by L. Kane to consider and approve EDU 0329, EDU 0330, and EDU 0331 as a block. MOTION PASSED with R. Schaeffer opposing.
