RAR 300: Visual Culture: Critical Practice and an unnamed course to be developed on the subject of Global Perspectives. Eliminate General Education Category V: Electives. Under Professional Education, eliminate ARU 227 – Visual Art in Human Development, ARU 245 – Curriculum Theory and Design for Art, and ARU 327 – Teaching Aesthetics. Add ARU 100 – Teaching Art and Visual Culture in Elementary Setting, ARU 200: Teaching Art and Visual Culture in

Middle School Settings, and ARU 300 – Teaching Art and Visual Culture

in High School Settings, and SPU 100-Special Education

Change category from Specialization- Foundations to Art Studio- Basic. Increase credits for this category from 12 to 15, adding an unnamed course

to be developed on the subject of Digital. Change category named Studio to Art Studio-Breadth. Restructure to require CFT 121 and FAR 111 only. Add one 2D Elective chosen from either CFT 131, FAR 151 or Far 131, one 3D Elective chosen from CFT 110, CFT 141, CFT 151, CFt 161 or FAR 171, and one Multiples elective chosen from ART 201, ART 330, FAR 141 and FAR 161. Remove Non-Studio category completely. Add Art Studio – Depth A with 6 credits to include 2 courses on the 200 level in concentration studios. Change the title of the Specialization Elective category to Professional Elective and delete the 30 hour observation requirement.

It was moved by D. Lynch and seconded by D. Rogers to consider and approve this proposal. MOTION PASSED. R. Schaeffer dissented with concerns including the unnamed courses in the program proposal.
