MINUTES OF THE FEBRUARY 26, 2004 MEETING

K. Johnston called the meeting to order stating there was a quorum.

GENERAL ANNOUNCEMENTS

K. Johnston announced the following changes to the Agenda:

LAS 03182 - delete from the agenda since the requested change in course title has been previously done.

GRD 0401 - remove from the agenda per a request from the Graduate Council and the Provost's Office.

Department of Library Science Checksheet - K. Johnston clarified that the total number of credits required for the Library Science with dual certification in Elementary Education degree is 126 credits.

J. White announced that the course numbers for the new ARU courses approved at last month's UCC meeting were changed from ARU 100, ARU 200, and ARU 300 to ARU 110, ARU 210, and ARU 310.

request to use FAR 383 as the suggested course number.

NEW BUSINESS

Proposed By-Law Change - K. Johnston indicated that she has received a request from the Advising Center to add a non-voting member from the Advising Center to the membership of the University Curriculum Committee. It was moved by R. Gray and seconded by D. Lynch to honor the request. After discussion, it was then moved by R. Schaeffer and seconded by J. White to table the request until the next meeting in order to give committee members time to think about the request. MOTION TO TABLE PASSED.
