repeated for up to 6 credits provided the same topic is not repeated.

Course: New Course - CHM 00X, Preparatory Chemistry, 3 s.h., 3 c.h. (effective

Spring 2005).

Proposal: Addition of course to master course listing. High school algebra is a course

prerequisite. Enrollment in this course is limited to science and science education majors who have not taken or who have not successfully completed General Chemistry I and the course will fulfill Categories IV. D. and V. of General

Education for those students.

Comments: There was a question about whether there are enough Instructional Resources

listed in the syllabus. It was also noted that none of the listed Instructional

Resources are currently in the Library.

It was moved by E. Rogol and seconded by K. Kresge to consider and approve this proposal. MOTION PASSED.

Curr #: LAS 03191

Program: Program Revision - B.S. Chemistry/Biochemistry (effective Spring 2005).

Proposal: Addition of CHM 230 to the Major Program, Category A, Required Chemistry

courses; addition of CHM 340 to the Major Program, Category C., Chemistry Electives; and deletion of CHM 340 from the Major Program, Category A.,

Required Chemistry courses.

It was moved by E. Rogol and seconded by K. Kresge to consider and approve this proposal. MOTION PASSED.

Curr #: LAS 03194

Course: New Course - MAT/WST 045, Women in Mathematics, 3 s.h., 3 c.h.

(effective Spring 2005).

Proposal: Addition of course to master course listing. Two years of high school algebra

is a course prerequisite. This course may be used to fulfill Category IV.D or Category V. in General Education. The course may also be used as an elective

for the Women's Studies Program.

Comments:

It was noted that the suggested course number of MAT 035 cannot be used since this course number was previously used. D. Lynch indicated that this is the type of course that the General Education Restructuring Committee hopes will be developed in the future.

Note: Subsequent to the meeting, it was determined that MAT/WST 045 should be used for the course number.

It was moved by D. Lynch and seconded by K. Kresge to consider and approve this proposal. MOTION PASSED.
