It was moved by K. Kresge and seconded by R. Gray to approve the Minutes of the April 22, 2004 meeting. R. Schaeffer noted that he should be marked as absent. The motion passed to approve the Minutes as amended.

Course: Course Revision - SPU 318, Special Class Methods (effective Spring 2005).
Proposal: Change in course number **from** SPU 220 **to** SPU 318. In addition, revision of course syllabus.
Comments: It was noted that the course description should be in sentence form.

Curr #: EDU 0422
Course: Course Revision - SPU 316, Reading and Other Language Arts for Exceptional Children (effective Spring 2005).
Proposal: Change in course number **from** SPU 222 **to** SPU 316. In addition, revision of course description and syllabus.
Comments: It was noted that the course description should be in sentence form.

Program: Program Revision: B.A. Political Science with Paralegal Studies, B.S. Public Administration with Paralegal Studies, B.S. Criminal Justice with Paralegal Studies, B.A. Psychology with Paralegal Studies, and B.A. History with Paralegal Studies (effective Fall 2004).
Proposal: Revision of the above checksheets by adding PLG 125, Workers' Compensation Practice for Paralegals, PLG 130, Social Security Disability Practice, and PLG 135, Interviewing for Paralegals, as elective courses under the Paralegal Studies section of the checksheet. Also, addition of the notation to the check sheet that PLG 1-credit courses must be taken together to total 3 credits.

Course: New Course - PAG 360, Pennsylvania German Studies Abroad, 1-6 credits (effective Fall 2005).
Proposal: Addition of course to master course listing. This course may be used by students with a major in German Studies and a minor in Pennsylvania German Studies. It will also be part of one course concentration within the German Language major. The course may also be used as an elective in General Education.
Comments: It was noted that the title on the syllabus does not match the title on the cover sheet of the proposal. W. Donner, who was present at the meeting to answer questions

relative to the proposals, indicated that the correct title should be Pennsylvania German Studies Abroad as listed on the cover sheet.

- Curr #: LAS 03205
Course: New Course - PAG 370, Readings in Pennsylvania German Life, 3 s.h., 1-3 c.h. (effective Fall 2005).
Proposal: Addition of course to master course listing. This course may be used by students with a major in German Studies and a minor in Pennsylvania German Studies. The course may also be used as an elective in General Education.
- Curr #: LAS 03206
Course: New Course - PAG 301, Pennsylvania German Literature, 3 s.h., 3 c.h. (effective Fall 2005).
Proposal: Addition of course to master course listing. This course may be used by students with a major in German Studies and a minor in Pennsylvania German Studies. The course may also be used as an elective in General Education. The course cannot be counted for credit with PAG 251.
- Curr #: LAS 03207
Course: New Course - PAG 251, Pennsylvania German Literature in English and Translation, 3 s.h., 3 c.h. (effective Fall 2005).
Proposal: Addition of course to master course listing. This course may be used by students with a major in German Studies and a minor in Pennsylvania German Studies. The course may also be used as an elective in General Education.
- Curr #: LAS 03208
Course: New Course - PAG 390, Internship in Pennsylvania German Studies, 3 s.h., 1-3 c.h. (effective Fall 2005).
Proposal: Addition of course to master course listing. This course may be used by students with a major in German Studies and a minor in Pennsylvania German Studies. The course may also be used as an elective in General Education. Junior or Senior status and permission of instructor if not a student with a minor in Pennsylvania German Studies are course prerequisites.
- Curr #: LAS 03209
Courses: New Courses - PAG 011/012, Introduction to the Pennsylvania German Language, 3 s.h., 3 c.h. for each course (effective Fall 2005).
Proposal: Addition of course to master course listing. This course may be used by students with a major in German Studies and a minor in Pennsylvania German Studies. The course may also be used as an elective in General Education.
- Curr #: LAS 03210
Course: New Course - PAG 010, Introduction to Pennsylvania German Studies, 3 s.h., 3 c.h. (effective Fall 2005).
Proposal: Addition of course to master course listing. This course may be used by students with a major in German Studies and a minor in Pennsylvania German Studies. The course may also be used as an elective in General Education.
- Comments: It was noted that reference to Pennsylvania German Studies Minor should be removed from the top of all the course syllabi and that the PAG prefix is missing from the syllabi. It was further noted that reference to the courses being applicable in Category V of General Education should be removed from the Rationale since there

may no longer be a Category V once the General Education revision is completed. W. Donner indicated that he would make the suggested changes to the syllabi and submit the corrected syllabi to the UCC office. G. Paterno noted that this prefix may be a problem in that it doesn't relate to a specific department.

It was moved by R. Gray and seconded by C. Lottes to consider and approve LAS 03204, LAS 03205, LAS 03206, LAS 03207, LAS 03208, LAS 03209, and LAS 03210 as a block. MOTION PASSED.

Curr #: LAS 03203
Program: New Program - Minor in Pennsylvania German Studies (effective Fall 2005).
Proposal: Addition of new minor in Pennsylvania German Studies consisting of 18 credits.

It was moved by C. Lottes and seconded by K. Kresge to consider and approve this proposal. MOTION PASSED.

Curr #: LAS 03211
Course: New Course - GER 360, Study Abroad Experience, 1-6 c.h., 1-6 s.h.
Proposal: Addition of course to master course listing. A student with major in German Studies may take the course for 1-6 credit hours with approval from the advisor. A student with a minor in German Studies or seeking a concentration in German may take the course for 1-3 credit hours with approval from the advisor. This course is available only to students majoring, minoring or earning an Elementary Education concentration in German who complete an approved study abroad program and meet evaluation standards approved by the German advisor.

Comments: It was noted that everything except the first and last sentence of the Rationale should be removed from the syllabus.

Curr #: LAS 03213
Course: New Course - GER 390, International Internship in German, 1-9 c.h., 1-9 s.h.
Proposal: Addition of course to master course listing. Enrollment as a German major, permission of the department chair and advisor, junior or senior status, and a 2.5 GPA in major or 2.0 GPA overall are course prerequisites.

Comments: It was noted that everything except the first and last sentence of the Rationale should be removed from the syllabus.

It was moved by G. Paterno and seconded by K. Kresge to consider and approve LAS 03211 and LAS 03213 as a block. MOTION PASSED.

Curr #: LAS 03212
Program: New Program - BA/German Studies: Pennsylvania German Culture in America Track, BA/German Studies: Interdisciplinary Track, and BA/German Studies: Communication and Culture Track

Proposal: Addition of three tracks under the BA/German Studies program: Pennsylvania German Culture in America Track, Interdisciplinary Track, and Communication and Culture Track.

Comments: Due to the fact that the cover sheet listed only one track, it was noted that a new cover sheet will need to be forwarded to the UCC Office listing all three tracks.

It was moved by M. Stewart and seconded by G. Paterno to consider and approve this proposal. MOTION PASSED.

Course: Course Revision - ENV/CHM 221, Environmental Analysis Lab (effective Spring 2005).
Proposal: Revision of the number of laboratory hours for the course from four hours to three hours. This change will not alter the number of semester hours for the laboratory.
