Minutes of the Faculty Senate  
February 4, 1983

Chairperson W. Marsh called the meeting to order at 4:05 p.m. Present were: C. Arnold, P. Briere, R. Buckalew, D. Dahlman, F. Dreisbach, E. Earley, E. Evans, L. Friedman, C. Gearhart, A. Gundry, L. Halma, G. Innocenti, J. Johnson, S. Keiser, E. Kern, R. Lucas, P. Malpas, W. Marsh, A. Matz, A. McKinley, S. Ottinger, E. Reeves, J. Richards, T. Schantz, S. Schneider, A. Schutt, G. Sharp, R. Spang, S. Tibbits, J. Treadway, L. Trollinger, R. Wittman, and C. Yarrison.

Others in attendance were: T. Johnson, Student Government representative, R. Law, and D. Lenhart for P. Ori.

I. Announcements

Chairperson Marsh read the memorandum from President Stratton concerning Commencement 1983: "Due to the request of the overwhelming majority of graduating seniors, the class officers, and the advisor to the class of 1983, an expanded Commencement Committee has recommended that we read the names of graduating seniors at Commencement. To accommodate this request, Commencement on Saturday, May 21, will be moved from 2:00 p.m. to the cooler hour of 10:00 a.m. The luncheon for honors graduates will be changed to an 8:00 a.m. breakfast. It is expected that the Commencement will maintain the same dignity it has always had."

II. Agenda

S. Tibbits moved to amend the tentative agenda to include Reconsideration of the Summer School Proposal under New Business. P. Briere seconded the motion and the agenda as amended was approved.

III. Minutes

L. Trollinger moved, A. Schutt seconded the approval of the minutes of December 2, 1982. Motion passed.

J. Johnson moved the approval of a resolution that upon the occasion of course revisions being presented to the Faculty Senate, that the minutes of the Faculty Senate and the Notice of Faculty Senate action which is sent to the President of the College include a listing of

courses to be deleted from the curriculum and the effective date of all course revisions.

The motion was seconded by E. Earley. E. Evans informed the Senate that the Motion was out of order in regard to the agenda; this was duly noted. Motion was voted upon and was passed with abstentions for S. Ottinger and E. Evans.

#### IV. Faculty Affairs Committee

E. Evans presented the report of the Faculty Affairs Committee.

#### V. Curriculum Affairs Committee

1. E. Earley moved the approval of the Anthropology/Sociology proposed revision for Social Foundations of Human Behavior to be offered as Soc 2\_\_ in its revised form, replacing Soc 461. (Soc 461 to be deleted at the end of the current semester.)

E. Kern seconded the motion which was approved.

2. E. Earley moved the approval of Mus 3\_\_ Field Experience in Music, seconded by S. Tibbits. The course was approved.

3. E. Earley moved the approval of Eng 121 C - Current Themes in Literature: American Writers and the Environment, seconded by S. Keiser. The motion passed.

4. E. Earley moved the approval of the Revised Program of Concomitant Courses for L.A. Majors in English. The motion was seconded by S. Keiser.

P. Malpas moved to amend the listed Music History to read "Music History and Literature" seconded by L. Trollinger. The amendment was passed.

The original motion as amended was approved. (The revision is to take effect September 1, 1983.)

5. E. Earley moved the approval of the curriculum changes recommended by the Department of Telecommunications:

a. Change the number of TVR 140 Introduction to Telecommunications to TVR 010.

b. Change the title of TVR 200 Advanced Television Production Techniques I to Intermediate Television Production and to add TVR as a prerequisite for TVR 200 and TVR 210.

- c. Change the title of TVR 210 Advanced Television Production Techniques II to Advanced Television Production.
- d. Change the title of TVR 300 On Campus Internship to Television Production Workshop.
- e. Divide the 14 semester hour course TVR 390 Senior Internship into two separate courses TVR 390 Senior Internship (12 s.h.) and TVR 380 Senior Seminar (2 s.h.) and to revise the TVR 390 Course Description and prerequisites.

R. Buckalew seconded the motion which was approved.

- 6. E. Earley moved the approval of TVR 380 Senior Seminar, seconded by D. Dahlman.

E. Kern moved to amend the proposal by removing the Course Rationale as presented and moving the second sentence of the Course Description, "This course serves as a preparation for the comprehensive examination in telecommunications." under Course Rationale. D. Dahlman seconded the amendment which passed.

The original motion as amended was approved. (All of the above Telecommunications changes to take effect September 1, 1983.)

- 7. E. Earley moved the approval of the two graduate courses, TVR 590 Internship in Telecommunications and TVR 570 Independent Study. D. Dahlman seconded the motion which was approved.

#### VI. Old Business

E. Earley moved to remove the course Pe/RA 2\_\_ Dance Through the Ages from the table; J. Johnson seconded and the motion passed.

D. Lenhart moved to amend the Course Format and Content by deleting item 6. "Isadora Duncan," renumbering the section immediately following as 6. Early Revolutionaries and inserting Duncan as item A. Thus:

- A. Isadora Duncan
- B. Denishawn
- C. Rudolf Laban; Kurt Jooss; Mary Wigman

R. Buckalew seconded the amendment which was passed.

As amended the original motion was approved.

VII. New Business



E. Evans moved to refer the matter to the Senate Committee on Academic Affairs, seconded by S. Ottinger. This motion took precedence over the preceding motion and was approved.

R. Buckalew moved to adjourn, seconded by J. Johnson. Motion passed. The Faculty Senate adjourned at 4:43 p.m.
