Comments: B. Herbine was here to speak of this change. Changes include:

The addition of ELU 202 as a required course under Professional Courses. Transfer ELU 201 from *Section 5 – Professional Courses* to *C. Specialization*, where it becomes ELU 300. In addition, ITC 125 and ITC 331 are deleted as requirements and ITC 321 is added as a requirement under *C. Specialization*. R. Gray spoke in opposition to the merging of two ITC courses into one. The grid Change is to provide better visual organization. The Free Electives is a symbolic Representation for transfer students to indicate relevant courses taken at another college or university. Credits listed under Free Electives do not count toward the 120 credits needed for graduation. E. Rogol requested *(OPTIONAL)* be appended to the *Free Electives* label on the check sheet.

It was moved by R. Gray to table this proposal. The motion did not receive a second. It was moved by B. Herbine and seconded by D. Lynch to consider and approve this proposal. MOTION PASSED with R. Gray dissenting.

Course: Program Change: B.S. Ed in Secondary Education Social Studies

Proposal: Change in program grid for Secondary Education Social Studies as well as

requirement changes, elective changes, and change in credit hours.

Secondary Education/Social Studies major in anticipation of the PA Department of Education reactivating the Social Studies certificate.
