MINUTES OF THE NOVEMBER 30, 2006 MEETING

Randy Schaeffer called the meeting to order stating there was a quorum.

GENERAL ANNOUNCEMENTS

R. Schaeffer welcomed Kathryn Holland as the new Graduate Council Representative replacing Robert Gray.

MINUTES

It was moved by C. Lottes and seconded by D. Lynch to approve the minutes from the October 26, 2006 meeting. V. Brancato noted a correction on page 3, last sentence, that the version should be changed **from** 20073 **to** 20083. The minutes were approved as amended. MOTION PASSED.

OLD BUSINESS

R. Schaeffer received a memo dated November 17, 2006, from Dr. Michael Gambone, APSCUF-KU Representative Council President, that all the Bylaws Revision has been approved by the Council. Three changes to the UCC bylaws were approved. First, an assessment section will be required in all course proposals beginning with routing numbers for the 2008 academic year. The membership of the Committee will now include one non-voting representative from the KU Advising Center, a position currently held by V. Brancato. Last, a new category and process was approved for Educator Workshop courses (EDW). These courses can now be offered multiple times; however a complete proposal must be submitted to the UCC as an announcement each time the course is offered.

R. Schaeffer will articulate details and examples of these changes in the bylaws for review at the January 2007 meeting.
