Blaque noted that there is a similar course taught in the History Department; P. Kelleher stated that the History Department has no objections to this course. R. Schaeffer noted that a comma was misplaced in the Course Rationale.

Hughes stated that it was necessary, and the committee agreed to make the date Aug. 25, 2014, so that it would be effective for the Fall 2014 semester.
