Minutes of the Faculty Senate April 4, 1985

Keiser withdrew the motion following discussion by R. Wittman and G. Goldberg. Minutes of the Faculty Senate

R. Wittman moved, seconded by R. Brumbaugh, to amend the motion to have the second sentence read "We therefore, ask the President to request the Curriculum Committee to reconsider its by-laws to reflect this historical role." The motion passed unanimously.

L. Ladd-Kidder moved, seconded by P. Ori, to amend the motion to delete the last sentence of the recommendation. The following people spoke to the motion: J. Schellenberg, S. Keiser, M. Kern, M. St. John, P. Ori, G. Goldberg. The motion failed 18-12, with R. Wittman abstaining.

R. Wittman moved, seconded by G. Innocenti, to amend the motion adding "and curriculum" after "university policy". The motion passed by a majority.

The main motion passed, as amended, by a majority.

J. Schellenberg moved, seconded by R. Brumbaugh, to send the proposal for a Document on Faculty Standards to the Faculty Senate Committee on Faculty Affairs.

J. Tinsman spoke to the issue.

The motion passed unanimously.
