Minutes of the Faculty Senate April 10, 1986

Chairperson Valuska called the meeting to order at 4:05 p.m.

  D. Valuska apologized for the delay in receiving the agenda and minutes for the meeting. There was a delay in the minutes being returned from the printing office.

  - D. Valuska read the following memorandum from Dr. Stratton to Members, Faculty Senate and Executive Committee, APSCUF, dated March 25, 1986:

On Thursday, April 17, Dr. James H. McCormick, Chancellor, State System of Higher Education, will be visiting Kutztown University. You are cordially invited to meet with him at 11:00 A.M. in the Rohrbach Library Auditorium.

D. Valuska read the fellowing memorandum from Dr. Stratton to Dr. David Valuska, President, Faculty Senate and Members, Faculty Senate, dated March 26, 1986:

I have received and reviewed the recent action of the Senate (March 6, 1986) concerning the proposed revisions of the Textbook Requisition Policy.

The opening statement which states that the policy "will apply only to these faculty choosing to order through the Student Cooperative Bookstore" can not be accepted. This proposed action of the Senate directly counters the previously approved and implemented policy.

With full respect for the consideration and action of the Faculty Senate, I must reject its recommendation of March 6 and state thereby that the Textbook Requisition Policy, dated January 16, 1986, as distributed by Vice President Wittman under the date of 1/17/86 is in effect.
