Minutes of the Meeting of the Faculty Senate
5 May 1977

The Faculty Senate held its regular meeting at 4:00 P.M. on Thursday, 5 May 1977, in the Library Science Reading Room of the Rohrbach Library, Chairman Hunkins presiding.

The Chairman called the meeting to order and asked for a motion to adopt the agenda. Prof. McIntyre so moved. After Prof. Engelson's second, the motion carried.

I. APPROVAL OF THE MINUTES OF THE MEETING OF 14 APRIL 1977

Dr. Evans/Prof. Ottinger moved to approve the minutes of the last meeting. The motion carried.

II. ANNOUNCEMENTS

Prof. Felkay asked that all ballots in the election of Senators be in no later than 6 May 1977.

The Chairman distributed a letter from Barry Venturella, President of the Student Government Board, concerning final examinations.

III. NEW BUSINESS

A. Approval of the list of May 1977 graduates

Dr. Dreisbach moved to approve the tentative candidates for the bachelor's degree, contingent upon their meeting all requirements for their respective degrees. Following Dr. Bucci's second, the motion carried.

Dr. Hershberger moved to approve the tentative candidates for the master's degree, contingent upon their meeting all requirements for their respective degrees. Following Dr. Law's second, the motion carried.

B. Report from the Senate's Curriculum Affairs Committee

1. Items from the College Wide Curriculum Committee

Dr. Ramsey presented and moved the approval of each of the following:

- a. The following three courses:
Music 2 --, Physical Properties of Sound, 3 s.h.
P.E. 135, Aquatics for Children, 1 s.h. (with the substitution of new course objectives and a new syllabus) Anthropology 1--, The Anthropology of Death and Dying, 3 s.h.

Following Dr. Law's second, the motion passed.

- b. Art 3 --, Field Experience in Art, 1-18 s.h.
Prof. Keller seconded the motion. After some discussion, Dr. Evans moved that any credit be counted only toward the major. Following Dr. Worrell's second, the amendment passed. Dr. Evans then moved to refer the course again to the Senate's Curriculum Affairs Committee. After further discussion, there being no objection from the Senate, Dr. Evans withdrew his motion and Dr. Monroe his second. Dr. Dreisbach then moved to table the course until both department chairmen are present. After Prof. Scott's second, the tabling motion carried.
- c. Th. 2--, Theatre Workshop in England, 3 s.h.
Following Prof. Burwell's second the motion carried.

2. Items from the Graduate Council

Dr. Ramsey moved the approval of the following graduate courses:

- Bio. 5--, Biology in the Secondary School, 3 s.h.
- Ed/Soc S. 5--, Teaching Models for Social Studies Instruction, 3 s.h.

Following Dr. Hershberger's second, the motion passed.
