Minutes of the Faculty Senate October 1, 1981

Chairperson E. Earnest Foust called the meeting to order at 4:05 p.m. Members present were: R. Wittman, J. Johnson, E. Kern, M. Burkett, G. Schaeffer, R. Weiss, E. Earley, S. Keiser, C. Craig, P. Kendall, A. McKinley, S. Mack, L. Halma, P. Malpas, P. Ori, M. Varma, J. Treadway, R. Voytas, R. Grabowski, R. Crisson, D. Dahlman, J. Collier, M. Kern, A. Mazzaferri, J. Richards, E. Evans, A. Gundry, T. Schantz, and L. Trollinger.

Also present were: S. Westmoreland for T. Jentsch, G. Layser for T. Seay, and R. Briody for the Departments of Criminal Justice, Social Welfare, and Philosophy. M. Copman, Student Government President, was in attendance.

B. MacAdam and D. Lenhart of the Health and Physical Education Department, C. Arnold of the Foreign Language Department, and T. Hartz of the Business Administration/Economics Department were also present.

J. Johnson moved and S. Mack seconded a motion to approve the agenda. The motion carried.

1. Announcements

Chairperson Foust announced the following replacements on the Faculty Senate: G. Layser for T. Seay, M. Kern and J. Richards for D. Dunn and R. Whitcomb. The representative for Criminal Justice, Social Welfare and Philosophy will be elected next week.

Chairperson Foust announced that a communication from Dr. Stratton stated that he is approving the modification of the MPH Certification Program dated September 18, 1981.

Chairperson Foust announced the appointment of Gerard Innocenti as the Faculty Senate representative to the College-Wide Election Committee.

- 2. G. Schaeffer moved that the minutes of September 10, 1981, be approved. E. Evans seconded the motion which passed.
- 3. Balloting for two representatives to the Campus Traffic Bureau and one representative to the Student/Faculty Judiciary took place with these results:

Campus Traffic Bureau: Margaret Waible, George Burwell Student/Faculty Judiciary: Edward Earley

4. Curriculum Committee

P. Kendall, Chairperson of the Curriculum Committee, moved that the foreign language course proposals, Spanish Composition and Conversation A & B, and German Composition & Conversation A & B, be approved. E. Earley seconded the motion. It was noted that course numberings may be changed from those given. The motion carried. P. Kendall moved and J. Treadway seconded a motion to approve a proposal which would allow PE 003 & PE 004, Rhythmics I & II, to fulfill physical education requirements. The motion carried.

P. Kendall moved and A. McKinley seconded a motion to approve two new course proposals, History 2___ Civil War and Reconstruction, and Bus 3___ International Marketing. The motion passed.

P. Kendall moved that a new course proposal, TH 2 ____ Scenic Design, be approved. R. Weiss seconded the motion which passed.

E. Kern moved that the Academic Affairs Committee of the Faculty Senate re-examine the general education component of the undergraduate curricula in order to clarify which courses are and are not "hands on," distributive or restrictive, and other such topics germaine to this question. The intent is to clarify and adjust the application of courses to general education. R. Grabowski seconded the motion which carried.

- 5. R.Wittman moved that we accept the Advanced Placement Examination Policy Proposal. This proposal recommends test score cut-off grades and appropriate credit application and has been approved by the College Committee on Academic Affairs. J. Collier seconded the motion which passed.
- 6. Unfinished Business

C. Craig moved that the issue concerning the removing of Roman numerals from foreign language courses be removed from the table. E. Evans seconded the motion. After discussion P. Kendall moved and J. Johnson seconded a motion to return the proposal to the department for further consideration. The motion carried.

P. Malpas moved and S. Keiser seconded a motion to return the issues regarding the music course, Basic Concepts of Music, to the floor. Questions regarding the applicability of this course to general education requirements were resolved satisfactorily pending further study of the entire issue of general education.

After requesting the Senate Committees to convene briefly in order to elect chairpersons, Chairperson Foust adjourned the meeting at 4:50 p.m.
