I. APPROVAL OF THE MINUTES OF THE OCTOBER 6, 1977, MEETING

## III. NEW BUSINESS

1. Dr. Ramsey moved and Dr. Schantz seconded the motion to approve

as a unit the following courses and course name change:

Econometrics Introduction to Criminal Justice

Sp. 320 Studies in Oral Interpretation changed to Advanced Oral Interpretation

Dr. Hunkins moved and Prof. Teeters seconded the motion to amend the Prerequisites of Econometrics to read: "Econ. 11 and 12, Math. 121, and either Math. 140 or Bus. 20, or permission of the instructor." The motion to amend carried. The main motion carried.

2. Dr. Ramsey moved and Prof. Schellenberg seconded the motion to approve the "Proposed Changes in Endorsement Program in Environmental Education." After some discussion, Dr. Monroe moved and Prof. Erdmann seconded the motion to table the Proposal until a future meeting. The motion to table carried.

3. Dr. Ramsey moved and Prof. Banta seconded the motion to approve the proposal which would allow up to nine hours of Business Administration courses to be taken under General Education. After a lengthy discussion, Prof. Banta called for a secret ballot, the results of which were announced by Chairman Hunkins: 22 - NO; 10 - YES.

4. Dr. Ramsey moved and Dr. Moyer seconded the motion to approve the list of courses to be included in the new M. Ed. in Special Ed. The motion carried.

5. Dr. Ramsey moved and Dr. Moyer seconded the motion to approve the course, Field Experience in Special Education. The motion carried.

6. Dr. Ramsey moved and Dr. Moyer seconded the motion to approve the Master of Education Degree Program in Special Education. The motion carried.

At 5:25 P. M. Dr. Evans moved to adjourn, and Prof. Ottinger seconded the motion. The motion carried.
