Minutes of the Meeting of the Faculty Senate  
4 November 1976, continued 18 November 1976

The Faculty Senate held its regular meeting at 4:00 P.M. on Thursday, 4 November 1976, in the Library Science Reading Room of the Rohrbach Library. All items on the agenda not having been covered, the Senate continued the meeting at the same time and in the same place on 18 November 1976. Chairman Hunkins presided at both sessions.

Absent were one Senator: Prof. Patrick Duddy; and two Student Representatives: Tim Gruesel and Diane Kline.

The Chairman asked for a motion to adopt the agenda. Dr. Gilles so moved. Prof. Burwell seconded the motion. Dr. Monroe then moved to amend the agenda by moving the proposed revision of the Bachelor of Science - Communication from IV. A. (New Business, Items from the Curriculum Committee) to immediately after III. D.2. Following Dr. Law's second, the amendment passed. The motion then passed as amended.

I. APPROVAL OF THE MINUTES OF THE MEETING OF 7 October 1976

Professor Ottinger moved approval of the minutes provided two corrections were made: on page 1 in the list of Senators present, the surname of Dr. Dorothy Moyer appears as Mayer; and on page 2, III. A. line 3, the given name of Dr. Madan Varma appears as Madam. After Prof. Bonser's second, the motion passed, and the minutes stood approved as corrected.

II. ANNOUNCEMENTS

A. Prof. Raymond Heimbach will represent Business Administration/Economics, which is now a department and is therefore entitled to a representative in the Faculty Senate.

B. The elected chairmen of the standing committees are: Prof. George Burwell, Student Affairs; Prof. John Erdmann, Academic Affairs; Dr. William Worrell, Faculty Affairs; and Dr. Benjamin Ramsey, Curriculum Affairs.

C. For the purpose of information, the Chairman said that the Faculty Senate had received a letter from the President of the Student Government Board, Larry Ventrella, requesting student participation in departmental meetings. The Chairman, wanted to recognize Tim Gruesel, who was not present.

## III. OLD BUSINESS

- A. Report from the Senate's Ad Hoc Committee on the Report from the Committee on Campus Governance.

After a brief explanation of the nature and substance of Appendix A and Appendix B, the report from the Ad Hoc Committee, Prof. Felkay moved to remove from the table the motion passed in October to accept the original report. After Prof. Trollinger's second, the motion carried. Prof. Felkay then offered a substitute motion to amend the original report by acceptance of the recommendations reflected in Appendix B. Prof. Brunwell seconded the motion. Prof. Felkay moved to delete Recommendations W, G, and H, as indicated in Appendix A, and substitute the new Recommendation I in Appendix A for the original I. A long discussion followed. Dr. Monroe moved to table further consideration of the report. Following Dr. Evans's second, the motion carried.

- B. Report from the Senate's Faculty Affairs Committee on the Policy on the Use of Television.

Dr. Worrell, reporting from the Senate's Faculty Affairs Committee, read the following resolution into the minutes and moved its acceptance: "It is the opinion of the Faculty Senate that the documents setting forth the policies for the use of television on and off campus should have been considered by the Faculty Senate prior to the approval of the policies." Following Prof. Banta's second, the motion passed, with Dr. Dreisbach recorded as voting No. After recommending that the documents on the use of television be examined in detail, Dr. Worrell moved that the Senate refer both documents to the Senate's Faculty Affairs Committee for further investigation. After Prof. Kanasky's second, the motion carried.

- C. Report from the Senate's Curriculum Committee on the Policy on the Use of Television.

Dr. Ramsey, reporting from the Senate's Curriculum Committee on the Policy on the Use of Television, distributed a report but said that the Committee will present recommendations at the next meeting.

- D. Curriculum Committee Items Carried over from Previous Meetings.

1. Dr. Ramsey, speaking for the Senate's Curriculum Committee, moved the following amendment to the original proposal from the Department of Health and Physical Education: "It is recommended that the present Health requirement in General Education be modified so that students are permitted to satisfy it by electing one of the following Health courses: He 10, Health; He 50, Chronic and Communicable Diseases; or He 115, Health Maintenance through Diet and Exercise." After Dr. Hershberger's second, the amendment passed. The original motion (III. F. 3 on page 5 of October minutes) then passed as amended.
2. Dr. Gilles moved to remove from the table the motion to delete from the course outline of the proposed Ed 100, Perspectives on American Education (replacing Ed 010, Professional Orientation)

the following sections under I. The Philosophical Perspective: A. Basic Elements of Philosophy; B. The Nature and Value of Philosophy; and D. Major Philosophies; and the following sections under III. The Social Perspective: A. The Nature of Culture; and B. The Culture of the Community School. Prof. Bonser seconded the motion. At the request of Dr. Gilles, Dr. Shafer spoke in defense of the proposed course: he cited the two pages from the table of contents of a textbook--dittoed and distributed at the meeting--to defend the great breadth of the proposed course and to dispel the idea that too much is being included in the course; he argued that Educational Foundations is widely employed as a beginning course; and he pointed out that NCATE and the Pennsylvania Department of Education have mandated the upgrading of the course in basic education. Further he called attention to a revision of Part I of the course outline which all Senators had received and in which (1) Section B of Part I had been deleted, and (2) New Section B (old Section C) and new Section C (old Section D) had had the wording changed in order to try to make clear that the emphasis is on the relationship between education and philosophy and not on philosophy itself. Dr. Ryan also said that there would be no change in Part III of the original outline for the course. Then Prof. Watkins said that the Department of Social Science had decided unanimously to oppose the course as originally presented. The department's interest, he said, was in the quality of education, and the department failed to see that the proposal upgrades the course since it tries to do too much in too short a time and places an incredible demand on one instructor. In response, Dr. Gilles pointed out that Perspectives on American Education is a career course, not a liberal arts course. The course, she said, is an education course which asks students "to put on a different pair of spectacles." She also said that the course deliberately spells out "the many things we would like to touch upon" and that the Department of Education is not the first "to think of foundational disciplines." During the discussion Dr. Whitcomb said that he could now support the course, and Dr. Pawling said that the Department of Art Education supported the course. There followed a vote by ballot on the question: whether or not to delete Sections A, B, and D of Part I and Sections A and B of Part III. The results were 25 No votes, 8 Yes votes, and 1 abstention.

Dr. Gilles then moved to amend the original proposed course outline by substituting the revised version. Following Dr. Pawling's second, the motion carried, with a No vote cast by Prof. Watkins. Dr. Evans then brought up the matter of raising the number of credit hours from two to three. Dr. Shafer offered a brief defense. In the vote on the original motion as amended, there were 29 Yes votes and five No votes, the following four having requested to be recorded: Dr. Evans, Dr. Hunkins, Prof. Ottinger, and Prof. Watkins.

Dr. Monroe then moved to accept Item 14, Revision of the Communication Program in Secondary Education. Following Prof. Bonser's second and some discussion, the motion carried.

Dr. Dreisbach then presented the following proposed courses and moved their approval:

Art 390 - Art Student Teaching and Practicum (Revised), 14 s.h.  
After Dr. Pawling's second, the motion carried.

Art 315 - Metal Design (Revised), 3 s.h.

Art ---- - Leather Design, 3 s.h.

Art ---- - Serigraphy, 3 s.h. Following Prof. Ottinger's second, the Senate approved the above three courses.

Bus 009 - Introduction to Business, 3 s.h. Prof. Heimbach seconded the motion. Dr. Monroe then raised a question about Item 2 under Course Objections: "To lay to rest some of the misconceptions about business, especially with respect to the profit motive." After some discussion Dr. Dreisbach moved to amend the proposal by substituting a new Item 2 proposed by Dr. Monroe: "To consider critically the conflicting points of view concerning business." After Dr. Monroe's second, the amendment carried. The motion then passed as amended.

At 5:55 Dr Evans moved to recess until 4:00 P. M. on Thursday, 4 November 1976. After Prof. Bonser's second, the motion carried.

Absent were Senators: Dr. James Hershberger, Dr. Richard Law, Dr. Ruth Stickney, and Dr. Roger Whitcomb.

Before continuing with the business on the agenda, the Chairman announced that as a result of his haste on 4 November the Senate bypassed one important matter concerning the original Report on Campus Governance: before the Senate was Prof. Ottinger's main motion made in September on the original report to refer the report to a new ad hoc committee appointed by the Chairman. On 4 November, the Senate should have voted on the new ad hoc committee's recommendations as substitutions to the main motion. In December, the Senate will be voting on substitutions, not on amendments to the Constitution of the Faculty Senate.



## III. OLD BUSINESS, continued

D. Curriculum Committee items carried over from previous meetings, continued.

3. Dr. Dreisbach presented and moved the approval of Bus 3---, Retail Management, 3 s.h. After Prof. Heimbach's second, the motion carried.

E. Academic Affairs Committee items carried over from the previous meetings.

Dr. Dreisbach withdrew the first proposal but moved the approval of the recommendation from the Academic Affairs Committee on changing the quality point average required for students graduating with honors. Prof. Kanasky seconded the motion. Following some discussion, Dr. Monroe moved to refer the recommendation to the Senate's Academic Affairs Committee for study until early spring when the Committee would report its recommendations to the Senate. After Dr. Evans's second, the motion carried.

## IV. NEW BUSINESS

A. Items from the Curriculum Committee

Dr. Dreisbach presented and moved approval of the following:

1. Sp Corr 200 Language Disorders. Prof. Engelson seconded the motion. After some discussion, Prof. Goldstaub moved to amend the title to Language Disorders and Variations. Dr. Worrell seconded the motion to amend. After further discussion, Dr. Dreisbach moved to table the motion with the amendment until the December meeting so that the Department of Special Education can consider the entire matter. Following Dr. Evans's second, the motion carried.
2. El Ed 110, The Visual Arts Experience in Elementary Education (revised and retitled), 3 s.h. After Prof. Schantz's second, the motion passed.
3. Hist 011, History of Civilization A, 3 s.h.; and Hist 012, History of Civilization B, 3 s.h. The History Department, having encountered difficulties with the three-semester survey begun in the spring semester of 1974, is requesting reinstatement of the two-semester survey. After Prof. Collier's second, the motion carried, with Prof. Bonser voting No.

B. Items from the Graduate Council

1. Dr. Evans moved approval of a proposal to change the number of credits for Math 513: Inservice Mathematics from "3" to "1 to 3." After Prof. Ottinger's second, the motion carried.
2. Dr. Worrell moved approval of a proposal to add the following specified psychology courses to the Master of Education program in Social Science:

Psy 435 Psychology of Interviewing  
Psy 525 Developmental Psychology of Childhood  
Psy 545 Theories of Personality  
Psy 546 Psychopathology;

and to add the following course in Area I, Problems of Education in their Broad Settings, as an option in the four programs for the Master of Education Degree in the academic disciplines of English, Biology, Mathematics, and Social Science:

Psy 520 Advanced Social Psychology.

After Dr. Bucci's second, the motion passed.

- C. Dr. Bucci moved approval of a request from Dean O'Loughlin to run the evening courses for credit from 6:30 to 9:10 p.m. Prof. Burwell seconded the motion. After some discussion, Prof. Ori moved to terminate debate. After Prof. McKlveen's second, the motion to end debate passed. Dr. Bucci's motion then carried, with the following Senators voting No: Prof. Alagia (for Prof. Banta), Prof. Brasted, Prof. Ottinger, Prof. Sloat, and Prof. Watkins.

At 5:11 P. M., Prof. Watkins moved to adjourn. After Prof. Burwell's second, the motion passed.
