### I. Announcements

### II. General Education Proposal

Discussion continued with the Senate continuing to act as a committee of the whole to consider the proposed General Education Model.

#### **Category I. Basic Requirement, Section F, Computer Literacy**

Substituted motion approved at the November 7, 1996 Senate meeting: **To retain the requirement for computer literacy for graduation but by letting individual departments decide computer literacy.**

J. Schellenberg moved, J. White seconded, to amend the substituted motion from the November 7 Senate meeting **by reintroducing the amendment to move the 3 credits from Category I. Basic Requirement, Section F, Computer Literacy to Category V. Electives.** The motion to amend passed.

Substituted motion with amendment: **To retain the requirement for computer literacy for graduation but by letting individual departments decide computer literacy and to move the 3 credits from Category I. Basic Requirement, Section F, Computer Literacy to Category V. Electives.** The substituted motion passed as amended.

**Category I. Basic Requirement, Section D. Literature**

J. Schellenberg moved, K. McCloskey seconded, to remove from the table discussion of the amendment from the October 17 Senate meeting to **amend the original motion to affirm Category I. Basic Requirement, Section D. Literature by moving Category I. Basic Requirement, Section D. Literature to Category II. Humanities, Section C. and by moving Category II. Humanities, Section C. Elective to Category V. Electives**, thereby **changing the 21 s.h. under Category I. Basic Requirement to 18 s.h. and the 0-12 s.h. under Category V. Electives to 3-15 s.h.** The motion to amend failed.

The original motion from the October 17 meeting of the University Senate to **recommend the affirmation of Category I. Basic Requirement, Section D. Literature** passed.

**Category II. Humanities, Section A. Art/Music/Theatre**

J. Schellenberg moved, J. McGhin seconded, to **recommend the affirmation of Category II. Humanities, Section A. Art/Music/Theatre**. The motion passed.

**Category II. Humanities, Section B. F Lang/Philosophy/Speech**

J. White moved, B. Herbine seconded, to **recommend the affirmation of Category II. Humanities, Section B. F Lang/Philosophy/Speech**. The motion passed.

**Category II. Humanities, Section C. Elective**


E. Beaven moved, J. Cohen seconded, to **recommend the affirmation of Category II. Humanities, Section C. Elective**. The motion passed.
