# Minutes of the Faculty Senate December 3, 1981

Chairperson E. Earnest Foust called the meeting to order at 4:04 p.m. Members present: R. Wittman, J. Johnson, E. Kern, G. Schaeffer, R. Weiss, E. Earley, S. Keiser, W. Bleckmann, C. Craig, P. - $\it E.$  Evans moved that the agenda be approved. The motion was seconded by  $\it E.$  Kern and passed.

#### 1. Announcements

Chairperson Foust read a letter from E. Evans stating that his comments at the last Senate meeting were not meant to reflect unfavorably in any way on Dr. Mary Erickson, chairperson of the college Curriculum Committee.

- 2. E. Evans, seconded by C. Craig, moved that the minutes of November 5, 1981 be approved. Chairperson Foust noted that in the first sentence of the announcements "Faculty Affairs" should read Academic Affairs. The motion then carried.
- 3. Curriculum Committee

Chairperson P. Kendall moved that the proposal "Selected Topics in Music Literature," 4\_\_ be approved. L. Trollinger seconded the motion which carried.

- P. Kendall moved approval of these proposals:

  Department of Speech and Theatre--establish Th 132, Fundamentals of Acting, as a prerequisite to Th 233, Classical Acting Styles.

  Music Department--place Mu 020, Basic Concepts and Skills, under section D of the Related Arts Core Curriculum and under section B of the Related Arts requirements.
- R. Crisson seconded the motion which passed.
- P. Kendall moved that the proposed revision of the Criminal Justice Program presented by that department be approved. R. Voytas seconded the motion which carried.

#### 4. Academic Affairs Committee

Chairperson A. McKinley reported that the committee has been meeting regularly but is not yet ready to make its report concerning their examination of the general education component of the undergraduate curricula.

### 5. Faculty Affairs Committee

Chairperson A. Gundry presented the report from the committee and moved that the Faculty Senate accept its recommendation that the Ability Development Program staff and the Counseling & Psychological Services Department be seated on the Senate as soon as elections for representation can be held. R. Voytas seconded the motion which passed.

6. With no further business at hand, Chairperson Foust called for a motion to adjourn. E. Kern, seconded by A. McKinley, so moved. The meeting adjourned at 4:14 p.m.
