Paul A. Datti, PhD, CRC, HS-BCP, is an assistant professor of Counseling and Human Services at the University of Scranton, where he will be moving to associate professor effective August 2014. At Scranton, he directs the undergraduate Counseling and Human Services (CHS) program, and teaches in both undergraduate and graduate programs. He has been a Certified Rehabilitation Counselor since 1994 and a Human Services-Board Certified Practitioner since 2011. Dr. Datti graduated from Penn State's CACREP—accredited Counselor Education and Supervision doctoral program in December 2009, and has been working towards his LPC via continuing practice and supervision.

Dr. Datti has been a member of the Pennsylvania Counseling Association (PCA) since 2005, when he moved back to Pennsylvania after several years as a practicing counselor in New York, Washington, DC, and Miami, FL. He has been serving as President of a PCA division, the Pennsylvania Association of Lesbian, Gay, Bisexual, and Transgender Issues in Counseling (PALGBTIC), and as a PCA Executive Council Member since 2009. He also served as the PCA conference Co-Chair for the 2013 fall conference, and is an active member of the American Counseling Association (ACA).

In his time as President of PALGBTIC, the division expanded and grew, gained members and increased advocacy and outreach initiatives throughout the state; thus strengthening the voice of the division, assisting clientele who belong to the LGBT community, and advancing training specific to the population for counselors and other mental health professionals in Pennsylvania.
