Minutes of the Continuation of the Regular Meeting of 4 December 1975 18 December 1975

On Thursday, 18 December 1975, at 10:00 A.M., the Faculty Senate continued the regular meeting of 4 December 1975 in the Library Science Reading Room of the Rohrbach Library, Chairman Goldberg presiding.

Senators absent were Prof. Patrick Duddy and Dr. William Marsh.

APPROVAL OF THE MINUTES

Prof. Keller moved to approve the minutes of the first part of the meeting of 4 December 1975. Following Dr. Bucci's second, the minutes stood approved as submitted.

IV. C.2. Curriculum Committee Business (Section IV. C.2 of the minutes of 4 December 1975, continued)

The Faculty Senate continued the discussion of the $Program\ Proposal$ for the Degree in Art Education.

Dr. Dreisbach moved to amend Items 14 and 14-A in the following manner: reduce Instructional Materials and Methods in Art from four to three semester hours credit and replace Professional Orientation with the new foundation course. (Dr. Dreisbach reported that, according to a memo from Dr. Gilles, the Department of Secondary Education is preparing a new foundations course to replace Professional Orientation. Dr. Gilles said that the Department would meet on 5 January 1976 to consider the proposed new course.) After considerable discussion, Dr. Law moved to end the debate. After Prof. Ori's second, the motion passed. In a vote by ballot on Dr. Dreisbach's motion, there were nine votes Yes, twenty-four votes No, and no abstentions.

Dr. Pawling moved to substitute for the original 14-A a new degree program distributed on 4 December and entitled "B.S. in Art Education." Following Dr. Warzeski's second, the motion passed.

The Senate then voted on the motion which was still on the floor from the meeting of 4 December: the approval of 14 and 14-A. The motion passed as amended.

Dr. Pawling then moved to approve as a block Items 14-B through 14-Q, omitting 14-O. After Dr. Whitcomb's second, the motion passed.

Dr. Hunkins pointed out that an editorial change was necessary on 14-L under Course Description: "Art 320, Ceramics I" should read "Art 320, Ceramics II."

Dr. Pawling then moved to delete 14-R. Following Prof. Burwell's second, the motion passed.

Dr. Pawling then moved that Item 14-S be approved for a double prefix: Art and Theatre. Following Dr. Hershberger's second, the motion passed.

Dr. Pawling then moved to approve Item 14-0. Prof. Dreisbach seconded the motion. Dr. Pawling then moved to amend Item 14-0 by replacing the original bibliography with a new one. Following Dr. Hunkins' second, the amendment passed. Dr. Pawling then moved to amend the course description of 14-0. After Dr. Hunkins' second, the amendment passed.

Prof. Felkay then moved to table the consideration of Item 14-0. Following Prof. Engelson's second, the motion to table passed: twenty-two Yes, nine No, two abstentions.

Dr. Whitcomb then moved to refer Item 14-0 to the Curriculum Committee for clarification. Following Dr. Hershberger's second, the motion carried.

- 3. Dr. Dreisbach moved for the approval of a proposal from the Department of Mathematics to apply Math 135 to the mathematics major. After Dr. Hunkins' second, the motion carried.
- 4. Dr. Dreisbach moved for the approval of a new course entitled The Music of Poetry, with three credit hours. After Dr. Whitcomb's second, the motion passed.
- 5. Dr. Dreisbach introduced a proposal to change the prefix and title of Eng. 212 Journalism II to Eng./Sp. 212 Introduction to Mass Communications, and then moved for approval of the changes. Following Dr. Hershberger's second, the motion passed.
- 6. Dr. Dreisbach moved to accept a new course entitled The Age of Enterprise, 1865-1939, with three semester hours' credit. Following Dr. Hunkins' second, the motion carried.

7. Dr. Dreisbach then presented a proposal entitled Supplemental Series of Courses in Military Science or Aerospace Studies (ROTC) and moved for the approval of the proposal. Dr. Law seconded the motion. Dr. Gilles moved to amend the proposal so as to include students in the School of Education. Following Prof. Burwell's second, the amendment passed. Prof. Kanasky then moved to amend the proposal to include students in the School of Library Science. Following Dr. Law's second, the amendment passed. Dr. Hunkins then moved to amend page three (11. 10-11) to read: "6 credits may be allowed to be included in the total of 128 required for the bachelor's degree." After Dr. Law's second, the amendment passed. After considerable discussion, Prof. Brasted moved to terminate debate on the proposal. Following Dr. Law's second, the motion carried. The Senate then voted to approve the proposal as amended. The following Senators asked to be recorded as having voted No: Miss Chambers, Prof. Dreisbach, Prof. Foust, and Prof. Keller.

V. GRADUATE COUNCIL BUSINESS

- A. Dr. Drumm presented a course entitled The World of Humanism and Reformation submitted by the Department of History. Dr. Goldberg yielded the chair to Dr. Hunkins and then moved for the approval of the course. Following Prof. Dreisbach's second, the motion carried.
- B. Dr. Drumm presented another course from the Department of History:
 Ethnic Studies Workshop for Teachers: Curriculum and Materials.
 Dr. Goldberg moved for acceptance, and Dr. Hershberger seconded the motion. Dr. Gilles then moved to amend the motion to specify that approval be granted contingent upon receiving certain grants and only for the duration of the grants. Following Prof. McKlveen's second, and Prof. Sanelli's explanation of the grants, the amendment passed. The motion then passed as amended.
- C. Dr. Hunkins returned the chair to Dr. Goldberg and moved that the following minor curriculum revisions proposed by the Department of Mathematics be approved: "delete the requirement of Ed 580 in the M.Ed. program"; change the prefixes of Ed 580 and Ed 574 to MaEd 5--, the actual course numbers to be provided later.

The meeting adjourned at 12:30 P.M.
